ENTANDEM ensures that music creators and publishers are fairly compensated for the use of their works. An ENTANDEM license allows you access to virtually the world's entire repertoire of copyright-protected musical works. If you authorize the public performance of copyright protected-musical works without obtaining a performing right license, you are liable for copyright infringement. The SOCAN portion of the license is available for purchase with your membership and is valid through our fiscal year (Oct 1 – Sept 30) Cost: \$80.00 (Please be aware that on-line classes may not be covered under the Tariff 19 license.)
